# **EUROPE** The age of responsibility

A future for Europe. We are all aware of the need for new choices. Choices leading to policies that offer perspectives for all European citizens. Nowadays, 25% of young people in the EU are unemployed and uncertain about their future. The European economic crisis has only worsened their situation. The number of men and women living below the poverty line is ever-increasing. European policy responses have thus far proved insufficient. During the Fifth European Social Week, we seek to combine credible visions and political choices in three substantive parts.

The first part will investigate **which European Social Model** is best suited to overcome the actual challenges in society. The expansion of the world market over the last decades has led to more investments, more jobs, more innovation and more responsible ways of meeting human needs. However, despite this, we are stranded in a global economic, social, and financial crisis, which clearly indicates the limits and the inadequacies of such an extensive globalisation process.

How can we integrate solidarity and participation into a social model for the future on both the economic and social level?

How can we define the terms "solidarity" and "participation" and make them more relevant to contemporary challenges? How do we ensure these concepts, which were defined in the socio-economic context of the past decades, continue to have value and provide answers to contemporary challenges?

In the second part, we set out a vision for **an economy based on human capital in enterprises and business sectors**. Work ethics have changed worldwide. Increased competitiveness and flexibility increase pressure on workers. Those who cannot keep up with the pace of work and the knowledge levels, feel the threat of exclusion. The relation between employees and employers requires re-evaluation. How do employers deal

with the dilution of the rationalisation context, where employees are 'valued' based on their usefulness to guarantee the maximum profit for the shareholders? And how do employees and employers deal with the need for new flexibility, while it becomes more and more obvious that clinging to the image of the competitor as an 'enemy' will only lead to each other's downfall?

We recognise the need for new approaches and choices on this level. We want to discuss and share these with one another and defend our opinions.

It's my conviction that we live in a period of huge changes and new paradigms.

In this search we have to find a new and healthy balance between my own responsibility and our common responsibility.

In the third and final part, we will explore the **sustainable development of Europe in the world**. We do not consider Europe in isolation from the rest of the world. European choices must go hand in hand with: global human rights; conventions to fight climate change; requirements for healthy living standards; and ethical requirements for solidarity among all people. In this respect, we often clash on the classic contradictions between the economic and the political discourses. Economically, we accentuate the necessity of constant growth. In the debate on sustainability however, we reflect on reorientation and reduced consumption, which in turn leads to reduced growth. What are the essential individual and communal opportunities for us to seize?

**In each of the three parts an introduction speech is followed by three approaches.** Firstly: are there any additional elements in the analysis and what are options for the future? Secondly: the exploration of concrete models for action. Finally: what have Christian social traditions to offer as a source of inspiration for each of these three parts?

This European Social Week also wants to offer a platform to meet, debate, reflect and motivate all players of the Christian social field in Europe. The final goal is shaping a community where love, care, solidarity, creativity, responsibility, leadership, fairness and closeness prevail.

## SESSION 1. The European social model: which way to go?

Chair of the session: **Bartho Pronk** (The Netherlands), President of EZA.

The expansion of the world market can potentially lead to more investments, more innovation, more jobs and more responsible ways of meeting human needs.

However, the big question is whether this huge evolution would in practice also lead to a more harmonious world with more opportunities for humanity, for solidarity and fairness in cultures and civilisations. This is rarely the case.

Solidarity between rich and poor, between the strongest and the most vulnerable, is been replaced by 'the right of the strongest', resulting in a Europe where the rich became richer and the poor became poorer. There is a tendency towards the abolition of the social security systems, without taking into consideration the vulnerable position of many people. Additionally, we have to face the broad cultural evolution of Western civilisation. The quality of our Western civilisation is under pressure, because self- interests and consumerism often dominate an attitude of responsibility and participation. And yet these are precisely the characteristics which give heart to the democracy and the economy. And what about Europe as a Union in this context? In this age of crisis we're in, it is not guaranteed that a true Union will be established with 27 national States having their own language and history, with their own political and participative traditions and legal frameworks and with their different welfare systems. In an age of crisis, all these elements reduce the willingness for solidarity and cross-border redistribution.
